PRIVACY POLICY

This privacy policy (“Privacy Policy”) details the use, collection, disclosure of your information and the choices you have when using the [blog.binomoweb.com](https://www.binomoweb.org) website (hereinafter “Website”), operated and owned by Dolphin Corp LLC.

The information you provide is collected and processed by Dolphin Corp LLC, a company registered in accordance with the laws of Saint Vincent and the Grenadines with registration number 915 LLC 2021, located at Euro House, Richmond Hill Road, Kingstown, St. Vincent and the Grenadines (hereinafter referred to as as “We”, “Us” or “Our”).

We encourage you to read this Privacy Policy carefully. By using the Website, you fully and unconditionally agree to its terms.

1. Information we collect and use

We collect and use information about you (hereinafter referred to as “Your information / information about you”) as defined in this Privacy Policy and as necessary for the functioning and optimization of the Website, improving your experience when using it and which allows Us to comply with applicable laws and carry out our legal obligations.

1.1. When you use the Website, certain internet and electronic network activity information is automatically generated and recorded:

1. Like most websites, We use Cookies – small files placed on your computer, mobile device or any other device, which contain details of your browsing history on the Website.

2. When you access the Website, We receive information sent automatically by your browser (“log data”) such as Internet Protocol address, browser type, settings and configuration, date and time of your access, device data, including device type, system operation and settings, unique device identifiers, and other diagnostic data.

We use this information to optimize and improve your experience. Therefore, We analyze the technical operation of the Website and user activity on the Website, for example, We determine the frequency of visits to the Website and user preferences when accessing it.

1.2. You also share your information with us when:

You access and use the Website by voluntarily submitting certain types of content, including your name and (or) username, email address, telephone number, photos and (or) other images, comments (if such option is available via the Website);

You subscribe to our newsletter, contact us or fill out our questionnaire by providing your email address. In such cases We may also ask for your first and last name, telephone number;

You register to the Website through your account on the Binomo Platform by giving Us access to the following information only: Your account ID and current account status.

We use this information for the purpose of identifying you to support, maintain communications with you, including sending newsletters, digests, service (system) notifications and other information regarding use of the Website, and improve your experience on the Website.

2. How We share and transfer your information

2.1. Anyone can view the content you post on the Website. We may also share your information with:
